

Contract for Stylist – 50/50% Commission Split Basis

This Agreement is made and entered into on

Agreement Terms and Compensation:

1. Term of Agreement:

This Agreement shall be effective from the mentioned date and will continue until terminated by either party in accordance with Section 5 of this Agreement.

2. Compensation:

- a. The Stylist will receive a commission of fifty percent (50%) of the total revenue generated from hair services provided by the Stylist to clients at the Salon.
- b. The Salon will retain fifty percent (50%) of the total revenue generated from hair services provided by the Stylist to clients at the Salon.
- c. Commission payments will be calculated and paid to the Stylist on a bi-weekly basis. The Salon will provide a detailed breakdown of the services rendered and the corresponding commission earned. Payments will be made via direct deposit or as otherwise agreed upon by both parties.

Stylist's Services and Duties:

3. Services and Duties of the Stylist:

- a. The Stylist will provide hair styling services to clients of the Salon in a professional manner.
- b. The Stylist will be responsible for maintaining a clean and organized workspace.
- c. The Stylist will adhere to the Salon's policies and procedures, including but not limited to appointment scheduling, client consultation, and product usage.

Schedule and Termination:

4. Schedule and Availability:

- a. The Stylist will maintain regular working hours as agreed upon with the Salon.
- b. The Stylist will notify the Salon in advance of any planned absences or schedule changes.
- c. The Salon reserves the right to adjust the Stylist's schedule to accommodate business needs.

5. Termination:

- a. Either party may terminate this Agreement by providing written notice to the other party at least thirty (2) weeks in advance.
- b. The Salon reserves the right to terminate this Agreement for any reason, including but not limited to violation of Salon policies, misconduct, or poor performance.
- c. In the event of termination, any outstanding commissions owed to the Stylist shall be paid within ten (10) business days.

Confidentiality and Independent Contractor Status:

6. Confidentiality:

The Stylist will maintain the confidentiality of all client information and Salon trade secrets obtained during the course of their employment. The Stylist shall not disclose any such information to third parties, unless required by law.

7. Independent Contractor Status:

The Stylist acknowledges and agrees that they are an independent contractor and not an employee of the Salon. As an independent contractor, the Stylist shall be responsible for their own taxes, insurance, and any other obligations typically borne by independent contractors.

Entire Agreement:

8. Entire Agreement:

This Agreement constitutes the entire understanding between the parties and supersedes all prior discussions, negotiations, and agreements, whether oral or written.
